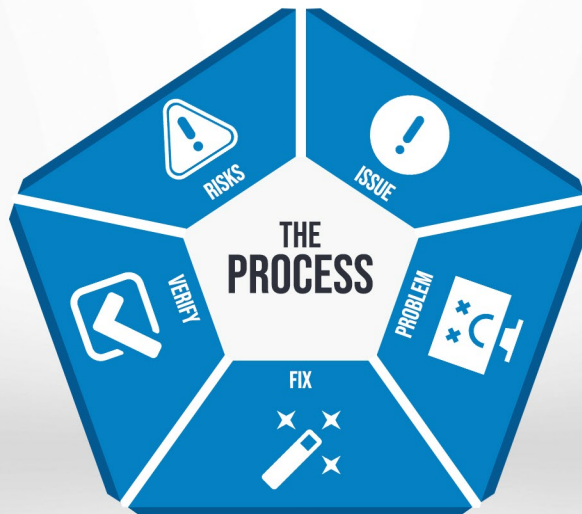




Corrective Action
